### **Wiltshire Council Local Plan Review and Gypsy and Travellers Plan Consultations.**

The Council has been advised that the Consultations (Period up to 2036) commenced on the 13<sup>th</sup> January 2021 and ends on the 9<sup>th</sup> March 2021. There were online engagement sessions to find out more of the potential sites in the area. There had been a need to sign up for the sessions, to be held using Microsoft Teams, and the sessions that would affect the Council's Parish were "Planning for Chippenham" 20<sup>th</sup> January 2021 and "Planning for Rural Areas" on 1<sup>st</sup> and 2<sup>nd</sup> February 2021. Council Members were emailed the details and the links to register. To receive any reports and

updates from attendees. Resulting from discussion being a Parish likely to be closely involved the Council agreed to hold this Meeting to consider a Council response within the timescale. **(For Decision)**

#### **Future Chippenham Consultation**

The Council has been advised of the Consultation. Wiltshire Council is keen to understand the views of Parish Councils affected by the Future Chippenham proposals and gave a presentation at the last Council Meeting to present details of 3 distributor road options. Resulting from discussion being a Parish likely to be closely involved the Council agreed to hold this Meeting to consider a Council response within the timescale. **(For Decision)**

#### **4. DATE OF NEXT MEETING:**

The date of next Council Meeting is scheduled for **Wednesday 24<sup>th</sup> March 2021**.

However, Members should note that at the present time the Covid-19 restrictions would prevent this from taking place in a public venue. Should the situation change Members will be advised. Members have agreed that Virtual Public Meetings will provide the opportunity for decisions to be made and allow the Council to carry out Council business.
